## 1. Overview

This document is a mandatory declaration for data vendor customers receiving Baltic Data via a vendor datafeed, requiring them to specify their Non-Display Usage (NDU) of the data.

All customers accessing Baltic Data through a datafeed (whether for NDU or display usage) must hold a Baltic Data License with the Baltic Exchange (Baltic). Customers will be billed directly by the Baltic for both the Data License and any applicable NDU application fees.

Failure by any customer to complete and return this form may result in the termination of the datafeed for that customer.

## 2. Charges and Billing

- Each non-display Application shall be billed separately.
- Baltic Data License fees charged as per client usage
- Billing frequency is annually in advance.
- Baltic reserves the right to back bill for historical noncompliant use
- This declaration does not cover any Third-Party usage. Any Third Parties using Baltic data will be required to license directly with Baltic for such usage

### **Reporting per Non-Display Application**

New customers must complete the declaration and have a Baltic Data License in place prior to receiving the datafeed from the vendor. The customer shall use its best endeavors to ensure the completeness and accuracy of all the information contained in each report.

Failure to complete this form accurately may result in the termination of the datafeed.
